

AS THE MAIN TOPIC OF SBF 2022

The focus is on EU countries (primarily Germany, Italy, Austria) as well as Switzerland, United Kingdom and Turkey. Having in mind the potentials of BiH and the region as attractive nearshoring destination for companies from the mentioned countries, BBI Bank together with domestic businessmen recognized nearshoring as an opportunity that can change the economic situation in the region in the coming years. Entrepreneurial people, educated workforce, natural resources, access to finance, as well as geographical and cultural proximity to major markets make BiH attractive enough to be a reliable partner to more economically developed countries. Companies from these countries should consider relocation of the production facilities from the other countries to BiH and the region, or enter into strategic partnerships with companies from the region.



BF connects companies from BiH and the region with companies and investors around the world, so these companies and their representatives are the main target audience. In previous years, SBF gathered over 10,000 participants. This year, the conference is also expected to be attended by a large number of renowned investors, institutional funds and statesmen from around the world, noting that the format of the conference will be adjusted to the epidemiological situation. 


he main aim of SBF is business networking and presentation of economic potentials of BiH and the region, and also opening the door for domestic companies to enter foreign markets. SBF is responsible for positive change the international image of BiH and the region and attracting many foreign investments in this area. The main goal of SBF 2022 is to present BiH and the region as attractive nearshoring destinations.

By transferring production to BiH, companies from the European Union minimize the risk of disruption in supply chains, compared to production on the Far East. We believe that the potential of nearshoring is closely and directly related to increasing foreign direct investment, increasing investment in the public sector, which would increase employment and ultimately stop the negative trend facing all countries in the region, i.e. the migration of capable workers to countries of the European Union. We consider nearshoring a historic opportunity for the countries of the region, both economically and geostrategically.



ypically, a cultural program is held in the City Hall a night before the main event. The formal part of the SBF starts in the building of the Parliament of BiH with messages from VVIP guests. This is followed by the award ceremony (for different award categories) and a panel discussion on current topics, which will continue on the second day of the SBF as well. The focus of the second day of SBF are B2B meetings, panels and company presentations.


